# CASINO SERVICING INDUSTRY NON-GAMING RELATED LICENSE EXEMPTION

NOTE:

A. THE COMMISSION MAY EXEMPT ANY PERSON OR FIELD OF COMMERCE FROM THE LICENSING REQUIREMENTS IF IT DEMONSTRATES THAT IT IS REGULATED BY A PUBLIC AGENCY OR THAT IT WILL PROVIDE GOODS OR SERVICES IN INSIGNIFICANT AMOUNTS OR QUANTITIES AND THAT LICENSING IS NOT NECESSARY IN ORDER TO PROTECT THE PUBLIC INTEREST OR ACCOMPLISH THE POLICIES OF THE ACT.

IN DETERMINING WHETHER TO GRANT AN EXEMPTION, THE FOLLOWING FACTORS WILL ALSO BE CONSIDERED:

- 1. NUMBER OF TRANSACTIONS
- 2. FREQUENCY OF TRANSACTIONS
- 3. DOLLAR AMOUNTS OF TRANSACTIONS: THE TOTAL DOLLAR AMOUNT OF SUCH TRANSACTIONS WITH ONE OR MORE CASINO LICENSEE OR APPLICANT IS OR WILL BE LESS THAN \$50,000 WITHIN ONE 12-MONTH PERIOD; OR NOT OVER \$120,000 WITHIN THREE CONSECUTIVE 12-MONTH PERIODS.
- 4. NATURE OF GOODS OR SERVICES PROVIDED OR BUSINESS TRANSACTED.
- 5. MAXIMUM POTENTIAL PERIOD OF TIME NECESSARY TO FULLY PROVIDE THE GOODS, PERFORM THE SERVICES, OR COMPLETE THE BUSINESS TRANSACTION.
- B. EXEMPTION FROM LICENSING REQUIREMENTS BY THE CASINO CONTROL COMMISSION IS STRICTLY DISCRETIONARY.

### INSTRUCTIONS

- 1. THIS APPLICATION SHALL BE COMPLETED BY ANY ENTITY DOING NON-GAMING RELATED BUSINESS WITH CASINO LICENSEES OR CASINO APPLICANTS WHO WISHES TO OBTAIN AN EXEMPTION FROM THE LICENSING REQUIREMENTS.
- 2. INFORMATION REQUESTS MUST BE ANSWERED COMPLETELY BY THE APPLICANT.
- 3. ALL ENTRIES ON THIS FORM, EXCEPT SIGNATURES, MUST BE TYPED OR BLOCK PRINTED IN BLACK INK. IF YOUR APPLICATION IS NOT LEGIBLE, IT WILL NOT BE ACCEPTED.
- 4. FOR PURPOSES OF THIS APPLICATION, "ENTERPRISE" OR "ENTITY" SHALL BE DEFINED TO INCLUDE ANY CORPORATION, ASSOCIATION, OPERATION, FIRM, PARTNERSHIP, TRUST, OR OTHER FORM OF BUSINESS ASSOCIATION, AS WELL AS A NATURAL PERSON.
- 5. SUBMIT AN ORIGINAL OF THIS ENTIRE APPLICATION FORM TO THE U.S. VIRGIN ISLANDS CASINO CONTROL COMMISSION ALONG WITH A FILING FEE OF \$100.00. IF THE COMMISSION DETERMINES THAT AN APPLICANT IS INELIGIBLE FOR AN EXEMPTION, THIS FEE WILL BE APPLIED TOWARDS THE NON-GAMING RELATED CASINO SERVICE ENTITY LICENSING FEE.
- 6. IT IS RECOMMENDED THAT YOU KEEP A COPY OF YOUR COMPLETED APPLICATION FOR YOUR RECORDS.
- 7. AN AUTHORIZED ENTITY MUST SIGN THE ACCOMPANYING VERIFYING AFFIDAVIT BEFORE A NOTARY PUBLIC.

BY THE SIGNING OF THIS APPLICATION, THE APPLICANT ACKNOWLEDGES THAT IF AN EXEMPTION CERTIFICATE IS ISSUED, IT WILL BECOME THE DUTY OF THE APPLICANT TO ABIDE BY AND COMPLY WITH ALL FEDERAL, STATE AND TERRITORIAL LAWS AS WELL AS THE RULES AND REGULATIONS PROMULGATED BY THE U.S. VIRGIN ISLANDS CASINO CONTROL COMMISSION AND THE DIVISION OF GAMING ENFORCEMENT, DEPARTMENT OF JUSTICE.

THE APPLICANT UNDERSTANDS THAT EACH EXEMPTION IS GRANTED ON CONDITION THAT THE ENTITY COMPLIES WITH SECTIONS 506 AND 507 OF THE VIRGIN ISLANDS CASINO AND RESORT CONTROL ACT (EQUAL OPPORTUNITY PROVISIONS).

THE APPLICANT AGREES TO COMPLETE A CASINO SERVICING INDUSTRY NON GAMING RELATED LICENSE APPLICATION IF REQUIRED BY THE COMMISSION OR WHENEVER THE DOLLAR AMOUNT OF EACH TRANSACTION WITH ONE OR MORE CASINO LICENSEE OR CASINO APPLICANT EXCEEDS \$50,000 WITHIN ONE 12-MONTH PERIOD OR OVER \$120,000 WITHIN THREE 12-MONTH PERIODS.
